#### Potential Health Effects

The toxicology of this compound has not been completely examined. It is presumed that the toxicity of this item is similar to other soluble gold compounds.

*Inhalation:* Unlikely because of the low vapor pressure.

*Ingestion:* While the toxicity of this compound is low, large doses may cause nausea, vomiting, diarrhea, etc.

*Skin contact:* Gold chloride is corrosive.

*Eye contact:* May be irritating

*Chronic Exposure:* Unknown

*Aggravation of preexisting conditions:* Unknown

### Section IV - First Aid Measures

*Inhalation:* Unlikely to be a problem. Remove from source of exposure and get medical attention for any breathing difficulty.
