Overview: May be harmful if swallowed. May be irritating to skin eyes and respiratory tract.

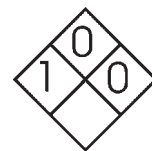

Potential Health Effects

Section IV - First Aid Measures

Inhalation: Not likely to happen.
